3. Proposed Modes of Collaboration

Jamuna Prasad Verma P.G. College, Bilaspur(C.G.) beyond the relationship specially created by this MOU. Unless specifically provided otherwise herein, no party, or representative shall be deemed to be a representative, agent or employee of any other party by contract, by employment or for any purpose what so ever.
- b) Both Atal Bihari Vajpayee Vishvavidyalaya, Bilaspur(C.G.) and Govt. Jamuna Prasad Verma P.G. College, Bilaspur(C.G.).agree to help, indentify and invite the faculty member and research from other institutes to participate in Conferences, Workshop and Short-term courses.
